

TIC SUMMER CAMP 2008 SHUTTLE between DC and Bethesda

A permission form must be filled out for EACH camper who takes the shuttle bus in 2008.

For the convenience of families in Washington, DC, TIC is offering shuttle service.

The bus picks up at:

- The parking lot of **Horace Mann Elementary School**, 4430 Newark Street NW, Washington DC 20016

Campers are returned to the same stop on the p.m. trip.

DEPARTURE TIMES

The bus departs from the church parking lot **at 7:45 a.m.** If you arrive at the bus stop early, wait with your child until the bus counselor appears. If you arrive after the scheduled departure time, you will have missed the bus, and TIC has no more responsibility for transporting your child.

The bus departs from Extended Day in order to arrive at the church **by 6:00 p.m.** (The time may vary due to rush hour traffic.)

IF YOU ARE LATE PICKING UP

On the permission form, please give us all relevant contact numbers (parents, friends or relatives, guardians, babysitters) including numbers of cell phones or pagers— whatever is necessary for anyone who may be contacted if a child is not picked up on time.

- If a child is not picked up by 6:00 the bus counselor will first call the TIC office, then the contact numbers.

Parents should call the TIC Office either at **(703) 798-5330** or **(703) 241-5542** to make arrangements for retrieving the child.

People who are late picking up their children will be charged \$10 for the first twenty minutes and \$1 for every minute after that, payable by check (made out to "TIC") when the child is retrieved from the bus counselor.

BUS RULES

Campers who ride the bus must follow our rules: (1) Remain seated with seat belt fastened at all times the bus is in motion. (2) Obey the TIC bus counselor. (3) Behave in a polite and orderly manner. We reserve the right to deny bus service to campers who break the rules or misbehave.

Our bus counselors have been trained to deal with accidents or any other disruptions. The drivers have commercial drivers' licenses and appropriate experience and training. We are fully insured, and TIC meets all of the American Camp Association accreditation standards for transporting children.

Please fill out and detach the permission form, keeping this part for your information. We must have permission for each child riding the bus. If you are sending two or more children on the bus, be sure to add all their names to the form.

Send the completed form(s) to the TIC Camp Office, 4620 Dittmar Road, Arlington, VA 22207 (or bring it to the bus on the first day—no child may ride the bus unless we have this form). It must be accompanied by full payment (\$200 round trip , \$125 a.m. or \$175 p.m. per child per session) unless you already paid when you registered for camp. No refunds will be given for withdrawals.
